Parade Request Application (ALL APPLICATIONS MUST BE SUBMITTED 30 DAYS PRIOR TO THE EVEN

Effective January 01, 2011 the Farmington City Code pertaining to Parades within the Farmington City Limits have been modified as follows:

9-5-35 DESIGNATED PARADE ROUTES, PARADE PER-NLT, AND CERTIFICATE OF NSURANCE REQUIRED

The City of Farmington shall have three designated parade routes;

Parade Route 1: Parade Line up from either the North Side of Reed Park, or E. Fulton St East of N. Gold St., the parade route is South on N. Gold St. one block, turning west on E. Fort Street continuing three blocks, turning North on N. Main St to E. Court St East to N. Gold St. ending at either E. Fulton or Reed Park

Parade Route 2: From the South Side of Reed Park South on N. Cone St one block, turning West on E. Fort St for four blocks, turning South on N Wall St., continuing and ending in Oak Ridge Cemetery.

Parade Route 3: Starting at the Bank of Farmington Parking Lot heading South on N. Main St. to E. Fort Street heading East to N. Cone Street turning North on N. Cone St. and ending at Reed Park.

- Public Entities, Civic Groups or Individuals wishing to hold a parade within the City Limits must submit a Parade Request Application to the City of Farmington a minimum of 30 days prior to the requested parade date.
- All parade request applications shall be accompanied by a Certificate of Insurance coverage denoting minimum liability insurance coverage in the amount of \$,000,000.00 (one million dollars) naming the City of Farmington as an additional insured.
- (D) All parades held in the City of Farmington shall be led and followed by an emergency vehicle with its emergency lights activated.
- Any entity failing to apply for a permit, or provide to the City the required Certificate of Insurance, shall be denied the opportunity to have a parade.
